# Safety Corner: Falls

Accident Prevention: Slips, Trips and Falls Second only to motor vehicle accidents, slips, trips and falls are the most frequent accidents leading to personal injury, including head or back injuries, broken bones, cuts, sprained joints or strained muscles.

The following are some simple ways to reduce the likelihood of a slip and/or fall on wet slippery floors:

- Use absorbant mats in entrance ways during inclement weather (make sure mats lie flat).
- Use cat litter, sand, or rock salt to spread on the ground to assist with traction. Keep it in your car and use outside your car door to prevent slipping when walking into and out of clients' homes. Use an empty water bottle to keep some in your work bag to use when exiting a home to prevent a fall.

If you must walk on a slippery surface:

# Walk like a penguin



- Wear proper footwear for better traction on slippery surfaces.
- Point your feet outward, keeping your center of balance under you.
- · Take slow, small steps.
- When transitioning between floor surfaces, the friction between the sole of the shoe and the floor surface lessens. Alter your stride to take shorter, slower steps.
- Use your feet as probes to detect possible slip, trip and fall hazards.
- ·Use rails or other stable objects that you can hold onto.
